MICHIGAN TOWNSHIP PARTICIPATING RISK REDUCTION GRANT PROGRAM

At a regular meeting of the Lyon Township Board, Roscommon County, Michigan, held at the Lyon Township Hall on the 19th day of May, 2021 at 7:00 p.m.

The resolution is offered and was moved by Board Member Carlson and seconded by Board Member Grier.

WHEREAS, Fire Chief Cleeves requesting approval to apply for a Risk Reduction Grant Program (RRGP), sponsored by the Michigan Township Participating Plan. The Risk Reduction Grant cycle opens April 1, 2021 and closes May 31, 2021.

WHEREAS, Fire Chief Cleeves will be named the project manager who will administer the funds through the townships clerk's office, be knowledgeable in the total project, and serve as a contact for the Par Plan.

WHEREAS, Fire Chief Cleeves has presented to the Board the description of the project including contractor/vendor itemized bids, a list of the items and services to be purchased. The total cost of the project is \$5235.89. The total amount of the RRGP grant is \$2500.00.

WHEREAS, The RRGP grant will specifically be used to purchase and install front and rear recording camera system.

WHEREAS, Chief Cleeves will follow the guidelines and Format of the specific grant application and has noted that this project will take approximately 90 days from start to finish to complete once the grant has been approved by the Michigan Township Participating Plan.

NOW, THEREFORE, BE IT RESOLVED: that the Township Board has been advised and has approved the writing of a risk reduction grant application by Fire Chief Cleeves, that the grant is sponsored by Michigan Township Participating Plan. Fire Chief Cleeves will be the project manager and serve as a contact for the Par Plan. The Grant will be used to install front and rear camera system with monitor to benefit and protect the township from false claims of accident as this system will record, and it is only accessible to review by the Chief / Assistant Chief
