AGENDA:

-Twp. Board comments will be first, and include a hand out explaining the differences between a STR Ordinance as a Police Power Ordinance or as a Zoning Ordinance.

-Public comment will then be allowed.

-After STR public input is received, the Twp board may then choose to take action on proceeding, and in what manner, with a STR Ordinance for Lyon Twp.

-The STR public hearing will then be closed.

-At the close of the Short-Term Rental Public Hearing, a second Public Hearing will be held to receive resident input to the Lyon Twp board on the potential creation of a No Fertilizer Application Setback Distance Ordinance for Lyon Twp. properties located along the shoreline and connecting waterways of Higgins Lake.

-After the potential no fertilizer application distance setback ordinance public input is received, the Lyon Twp. Board may choose to take action on proceeding with the creation of a no fertilizer application setback distance ordinance for Lyon Twp.


-The no fertilizer application set back distance Public Hearing will then be closed.
